	 Access to the competition site will only be granted to persons who have received their second vaccination (with Johnson & Johnson only one vaccination required) at least 14 days before the start of the event; only vaccinations with vaccines approved in the EU are recognised (e.g. not Sputnik V or Sinovac); or have recovered from a proven COVID-19 infection, provided the infection did not occur more than six months previously - if the infection was more than six months ago, they must provide evidence of a single vaccination; have a negative test for the Corona virus, whereby a certified rapid antigen test must not be older than 24 hours and a PCR test must not be older than 48 hours.
